
Your Path to Certification

- Pass each course with a score of at least 85%. You have 3 attempts to pass.
- Launch and complete America's Health Insurance Plans (AHIP) or Pinpoint Medicare Training from Producers' University

Switch to AHIP or Other as your CMS Medicare Training provider.

- You can also upload a certificate (from AHIP, Pinpoint or Gorman Health)
- Internal Reps you may only launch and complete the Pinpoint Medicare Training

AHIP Reimbursement

We are pleased to announce that Cigna Medicare will once again reimburse certification costs when certain requirements are fulfilled:

- To be eligible, you need to complete your 2021 certification on or before September 1, 2020, and
- Sell at least five, new net applications with an effective date of Jan. 1, 2021

After meeting those requirements, you will be eligible for several different levels of reimbursement based on the certification completed. Additionally, a certificate announcing your track completion will be available to print on-demand.

Reimbursement Rates:

- Complete Pinpoint Medicare Training and all Cigna-required courses to receive \$89.95 reimbursement
- Complete AHIP Training and all Cigna-required courses to receive \$125 reimbursement
- Complete Gorman Health Group Training and all Cigna-required courses to receive \$99 reimbursement

Regardless, your AHIP completion records should sync automatically to our system and you should not need to manually upload a certificate
